Exhibiting at Shasta Growers Association Saturday Redding Certified Farmers' Market is not permitted until application is approved by the SGA Board of Directors. You will be notified by phone, email, or mail of acceptance. If accepted you shall:

- A. Make no sales of products, raffle tickets or other fund raising items unless these items are approved by the SGA Board of Directors. If you are approved to sale products for fund raising, you will be expected to pay the 4% of total sales fee. Whether you sell fund raising items or not you will be exempt from paying SGA's \$30 annual membership and \$5 table fee and you will not be a voting member of the SGA.
- B. Provide your own canopy, tables, chairs, and signage to identify your organization.
- C. Canopy must be secured on all four sides with weights heavy enough to withstand winds sometimes experienced at the market.
- D. Make no solicitations outside of your assigned space. Do not approach customers while in communal walkways or other market booths.
- E. Prior to attending market you must notify the market manager by phone at(530) 226-7100 before 8 pm Thursday. Please identify yourself and organization, speak clearly, and provide a call back number. This does not guarantee you a space. If there is no space available for you, market manager will contact you by phone prior to Saturday's market.
- F. You must arrive at the Redding City Hall location before 7:00 am and be set up in your assigned space by 7:30. NO EARLY DEPARTURES ARE ALLOWED. Market closes at Noon.

Having read and understood the above application, we request permission to exhibit at the Redding Certified Saturday Farmers' Market. We have read and understand the Shasta Growers Association Rules and Regulations (www.reddingfarmersmarkets.com) and agree to abide by them and cooperate fully with the Board of Directors, Market Manager and Operations Coordinator. We fully understand the failure to do so will result in dismissal from the market. Limitation and /or denial to exhibit is at the discretion of the SGA Board of Directors and may occur at any time.
